

**Policy on Membership and Dues**  
**North American Bike-Share Association**  
**Revised June 30, 2014**

**Definitions:**

System = a branded bike sharing system offering bike sharing service through one website and payment system (i.e., Capital Bikeshare, Hubway, San Antonio B-Cycle, and Charlotte B-Cycle are separate “systems”).

Potential Voting Member = A public or non-profit entity eligible to be a voting member (defined in by-laws). There may be multiple Potential Voting Members in a System.

Eligible Business Activity = the business activities that qualify a for-profit business or other entity to become a Non-Voting Member (such as: operating a System, planning a System, bike and station hardware sales, back-end software and hosting, web development and hosting, insuring a System operator or owner, or selling System sponsorship or ad placement).

**Dues Structure:**

**Voting Member Dues = Base Dues + System Size Adjustment**

Base Dues = \$2,000 year

Each Voting Member pays base dues, regardless of the number of entities involved in a system. (i.e., if DDOT and Arlington County both want to be members, each pays base dues)

For Systems in planning phase or in initial two-year period following launch of a new system, base dues shall be reduced by half.

System Size Adjustment = \$2 per bike per year

Bike quantity = maximum number of bikes in service in System simultaneously in prior year.

Single-payment principle: The intent is to capture the full System size once and only once for each represented System, regardless of the number of Voting Members or Potential Voting Members in that System. Voting Members from same System are responsible for allocating the System Size Adjustment between themselves.

Exception: If the Voting Members from a System own, operate, or oversee less than 50% of the bikes and/or stations in that System, the System Size Adjustment will be reduced in proportion to their actual participation in ownership, operation, or oversight of the System. (i.e., if the only voting member from a 1,000-bike multi-jurisdictional system owned 10% of the bikes, that member’s System Size Adjustment would be \$2 x 100 bikes = \$200).

**Non-Voting Member Dues = Base Dues + Business Size Adjustment**

Base Dues = \$1,000 per year

Each Non-Voting Member pays base dues, regardless of the number of Systems they serve or the number of vendors involved in a System.

Business Size Adjustment: See chart below. Based on Non-Voting Member's gross revenue during the prior year from Eligible Business Activities. (Revenue from unrelated business activity is not included)
